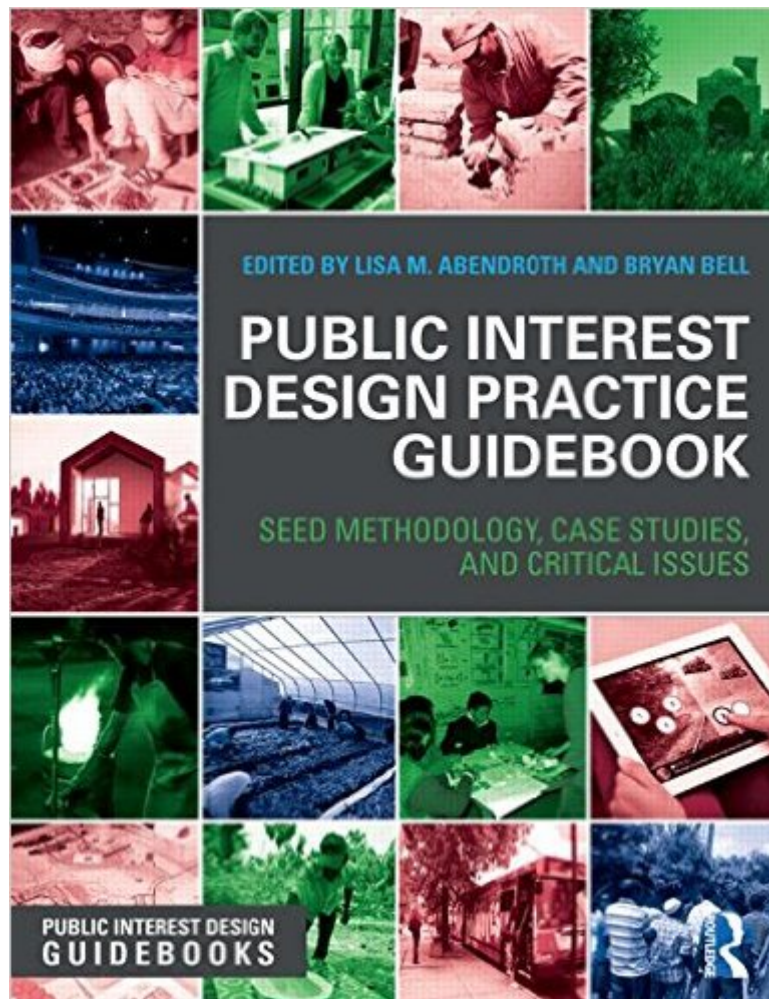

If you are a designer or educator who wants to better understand the practice of Public Interest Design - or a community member who wants to understand what to ask for when working with design professionals - this book is for you. If you have the desire to work with communities who do not often get a say in the way their physical environment is shaped - but you don't know where to begin - start here.

Public Interest Design Practice Guidebook: SEED Methodology, Case Studies, and Critical Issues introduces the standards and rigor that are needed to build Public Interest Design into a practice that has a major global impact. Included are the fundamentals, a step-by-step methodology and other tools. Groundbreaking is the documentation to lay out the case that "every issue is a design issue" which is supported by an index that covers 90 critical issues addressed by design. This is the third publication by Bryan Bell, and like his first two, this sets a new benchmark. While visionary the lessons are all grounded in real projects. Bell's first book, Good Deeds Good Design, 2003, proclaimed "Design for the 98% without Architects!" for the first time which has now become the rallying cry for this movement. In 2008, Expanding Architecture: Design as Activism called for designers to be pro-active and Tom Fisher introduced the term Public Interest Design. Lead editor Lisa Abendroth, a communication designer, brings clarity of message to the Public Interest Guidebook that will work for the professional, the student and most importantly the public.
